BUSINESS

It has been determined by the Committee that there will be four separate sessions of training on Homeless, Mental Illness and Youth, which will be approximately 2–2 ½ hours long.

Susan Stieber recommended a program called Virtual Hallucinations by Janssen Pharmaceuticals. The program offers people a chance to understand what it may be like for someone who experiences digital and auditory hallucinations. Susan is waiting for a call back from the representative at Janssen Pharmaceuticals to see if they offer a program for larger groups.

Mark Sakauye requested a snapshot of homelessness, which includes an overview on Homeless and Mental Illness. He asked for a scope of the following information:

- How many mentally ill and homeless people there are
- What services are provided
- What information could be given to them
- Who they could be referred to
- Something that would give perspective on what the Committee wants RT to know about those populations

Tim Brown provided a document* to be placed into the record called: 1) Street Sheet

Christina DeMoss-Giffin will put together the information pamphlets that are modeled like the bus schedules. The pamphlets will include resources to be placed in public transit.

Christina DeMoss-Giffin recommended the Youth Development Network (YDN) to support the development of the training modules as they pertain to Youth and if appropriate, the Mental Health and Homeless populations.

3. Information: Discussion of training curriculum (Sakaue)

Tim Brown recommended WIND Youth Resources.

Tim Brown recommended Loaves & Fishes to help train on the Homeless and Mental Health piece.

Mark Sakaue stated that training would most likely be held at Light Rail and RT Main.

Tim Brown stated that for the Homeless and Mental Health piece, three people would be needed to handle each training session.

Christina DeMoss-Giffin mentioned that for the Youth portion of the training, one person will train up to 15 people in a class.

Mark Sakaue asked Christina DeMoss-Giffin to provide Jennifer Kiamco with contact information for the Youth Development Network.

Police Services will type up the Homeless, Mentally Ill and Youth Outline which was written on the white board during the meeting. It will be distributed to the Committee and placed into the record.
