DISCUSSION

The Green Line to the River District is a project to extend a 1.1 mile segment of single track and construct two light rail stations. The purpose of the project is to bring light rail from downtown Sacramento through the future Railyards Development and the Richards Boulevard Redevelopment Area (Township 9). Green Line 1 (Project) is the first of three project phases planned to ultimately bring light rail from downtown Sacramento through the Natomas area to the Sacramento International Airport. Revenue service for Green Line 1 is anticipated to commence in early 2011.

AT&T has facilities located in or adjacent to the right of way. The Design-Builder, in consultation with RT staff, has determined that AT&T facilities require protection and/or relocation to construct the Project. AT&T will design and relocate its facilities under the proposed actual cost application. AT&T has provided an estimate of \$271,004.37 to perform the design and relocation work, but this is only an estimate and RT will be obligated to pay any excess amount if AT&T's actual costs exceed the estimate.

In order to prevent significant delays to Design-Builder, staff recommends the Board approve the AT&T Application for Green Line 1.
