DISCUSSION

On June 28, 2010, the Board authorized release of an Invitation to Bid (ITB) for Purchase of Outdoor Multi-Color LED Signs. Staff released the ITB on July 8, 2010 for 24 LED signs, with the option to purchase up to 48 additional signs, as funding becomes available, at the Bidder's unit price. The option will expire 12 months following the effective date of the contract.

RT intends to install the signs using its own workforce and has begun preliminary planning for installation of the signs. Based on efficiencies identified by staff in planning installation of the 24 signs to be purchased under the Principal Agreement, staff anticipates exercising an option to purchase 12 additional signs shortly after executing the Principal Agreement.

Staff recommends that the Board delegate authority to the General Manager/CEO to exercise an option to purchase the 12 additional signs and to enter into any number of amendments to the Principal Agreement that may be necessary to effectuate the purchase.

The included attachment to this issue paper lists light rail stations designated for sign installation.

Staff sent outreach notices to multiple firms and the solicitation was advertised in publications of general circulation. The solicitation was also posted on RT's website under Contracting
