DISCUSSION

On October 20, 2008, RT entered into a Contract for Project Assistant Services for the DNA Transitional Analysis with Koegel & Associates, to provide support for the Green Line to the Airport light rail extension project. Since then, Koegel & Associates has provided project assistance to RT in its mission to re-enter the Federal Transit Administration New Starts process for the Green Line to the Airport light rail extension project. The project assistance services work performed by Koegel & Associates includes: monitor and review contract deliverables for the Transitional Analysis work performed by HDR Engineering, Inc., assist with coordination of interagency communications and public outreach activities, provide weekly updates, attend RT staff and/or Board meetings, and all other duties as assigned by the RT AGM of Planning and Transit System Development. The total consideration identified in the Principal Agreement has been reached. However, due to ongoing activities on the Green Line project based on the project's current schedule, RT has a continuing need for Koegel & Associates' services. In order to ensure the continued availability of Koegel & Associates' services, RT must add funding to the Principal Agreement. The General Manager/CEO approved the First Amendment to the Principal Agreement under his authority which added \$2,848 in funding to the contract.
