Work Order 2 was issued to provide specialty track design support services for the South Sacramento Corridor Phase 2, which includes technical review of contract documents, preliminary engineering for design modifications, RT contract coordination, permit coordination, third party agreement coordination and utility coordination. The support provided by Psomas to RT staff is extremely critical to obtain authorization from FTA to advance into final design.

Work Order 2, Amendment No. 1, provides continuous support to RT for the advanced preliminary engineering of the South Sacramento Corridor Phase 2 project which has been extended beyond RT's original completion date and support. The support is needed for the FTA to grant RT entry into final design. These support services will also be needed for the anticipated redesign of the track alignment along the UPRR corridor to provide for the revised UPRR track center requirements.
