Yvonne Waites - Ms. Waites noted that Sacramento was receiving \$30 billion and this money was not earmarked for transit, but that she would contact her representative and she what she could do to help RT.

Mary Sutton - Ms. Sutton repeated Ms. Waites comments.

Jeffery Tardaguila - Mr. Tardaguila believes that RT still has an \$11 million dollar deficit. Mr. Tardaguila has issues with operators departing from stops when passengers are trying to catch the bus at 65<sup>th</sup> Street and Sacramento State. Mr. Tardaguila hears rumors that some union is getting an increase and that the CBS division has 5 supervisors for the 5 bus lines that are being operated. Mr. Tardaguila wanted to know what has become of the "discount" (bear bones) budget from last September. He also inquired as to how RT is going to mark/show discontinued bus stops.
