## DISCUSSION

RT was awarded a grant through the FY07/08 California Transit Security Grant Program (CTSGP) for improving its light rail station video surveillance system, installing a light rail corridor fiber optics communications system, and installing electronic light rail station passenger information signs. An informational status update to the Board on this project will be prepared for the next board meeting on July 26, 2010.

Staff has prepared an Invitation to Bid for 24 LED based passenger information signs based on internally developed technical specifications, with an option to procure up to 48 additional signs within 12 months of the effective date of the contract. Staff has recommended the purchase of IP Displays LED sign, model number IPLED32x128RG-ODBB-W, or approved equal, for this procurement. All salient characteristics necessary to determine product equivalency have been included within the ITB.

Staff recommends that the Board authorize staff to solicit bids for Outdoor Multi-Color LED Signs.
