Subject: Approving License for Bus Parking to San Joaquin Regional Transit District

ISSUE

Whether or not to Grant a License for two bus parking spaces in the P/Q Lot to San Joaquin Regional Transit District.

RECOMMENDED ACTION

Adopt Resolution No. 10-03-____ , Authorizing Execution of a License for Bus Parking with San Joaquin Regional Transit District.

FISCAL IMPACT

None

DISCUSSION

The San Joaquin Regional Transit District (SMART) has requested use of two spaces in RT's P/Q bus storage lot for weekday, off-peak parking of commuter buses. RT staff has determined that it can make the spaces available during the requested times, and that SMART's proposed use will not interfere with RT operations. Caltrans, as owner and lessor of the property between P and Q, 29th and 30th Streets, has consented to the proposed license. The license term will be 5 years which includes an early termination clause with 30 days notice, contingent upon RT securing a renewal of its existing lease agreement with Caltrans.

No charge for the license is proposed, since SMART is providing a transit service and because the terms of the Caltrans lease does not permit any income from shared uses.

Staff recommends adoption of the attached resolution, authorizing the General Manager/CEO to execute a license with SMART.
