Subject: Delegating Authority to the General Manager/CEO to Sign a Lease Agreement with the City of Elk Grove for Lease of Regional Transit Buses

ISSUE

Whether or not to authorize the General Manager/CEO to lease-ten up to fifteen buses to the City of Elk Grove.

RECOMMENDED ACTION

Adopt Resolution No. 10-11-____, Delegating Authority to the General Manager/CEO to Sign a Lease Agreement with the City of Elk Grove for Lease of Regional Transit Buses.

FISCAL IMPACT

This action would result in a minor savings to RT's operating budget resulting from a decrease in maintenance costs pertaining to buses in RT's contingency fleet.

DISCUSSION

This action would authorize the General Manager/CEO to enter into a lease agreement with the City of Elk Grove for the use of ten up to fifteen RT buses. These buses are being used as a temporary augmentation to the City of Elk Grove's bus fleet. They are replacing buses that were removed from service as a result of compressed natural gas fuel tanks that have exceeded their rated life and are no longer useable. They would be used by the City of Elk Grove for approximately eight months until refurbished and new buses are received.

As a consequence of reducing service in June of last year, RT has approximately 40 buses in a contingency fleet. RT's plan for restoring services would not require the use of these buses for at least eighteen months, which allows RT to enter into this lease agreement without any negative impact to RT's current service commitment. The lease will require the City of Elk Grove to maintain the ten buses, which are the subject of this lease. This results in a minor cost savings from the reduced cost of maintaining a smaller contingency fleet.

Because of the urgency of their need, the City of Elk Grove took possession of the ten buses on Saturday, October 16, 2010. This action would authorize the General Manager/CEO to sign the lease agreement once it is completed.
