### DISCUSSION

Work Order No. 8 (executed October 19, 2010) with Atkins (formerly PBS&J) was executed through RT's Engineering Support Services contract. Atkins is preparing an Initial Study/Environmental Assessment (IS/EA) for modifications in the proposed alignment for the South Sacramento Corridor Phase 2 (SSCP2) project. Due to additional IS/EA work requested by the Federal Transit Administration (FTA), the consultant's scope of work has expanded. This amendment will allow Atkins to do additional noise and vibration studies related to the various alignment options under consideration in the IS/EA and will also provide more staff time to address FTA questions and concerns related to this environmental work.

Staff recommends the Board approve Amendment 2 to Work Order No. 8 to increase the total consideration by \$87,340.58, from \$153,887.30 to \$241,227.88, and amend the scope of work to include additional activities necessary to complete the IS/EA.
