DISCUSSION

The California Department of Transportation (Caltrans) will be adding high occupancy vehicle lanes on both sides of Interstate Highway 80 (Del Paso Overhead Structures). The widening of these structures will interfere with RT's existing facilities.

On September 13, 2010, the Board of Directors approved a Service Agreement with Caltrans for RT to begin preliminary review the existing conditions and possible modifications to its overhead contact system (OCS) and wayside equipment to accommodate the bridge-widening work. Preliminary survey of the site confirms that the pole locations and wire height for the OCS will

require adjustment and the wayside equipment will need to be modified. While that Agreement was executed by all parties, Caltrans did not obtain the necessary internal approvals for the document.

Caltrans has since requested that RT complete the engineering design effort for the modifications to RT's system. RT will procure engineering design consultants to develop detailed modifications to RT's OCS and wayside equipment to eliminate interference between the OCS/wayside equipment and the Del Paso Overhead structure. RT will be providing design oversight.

The new Service Contract will cover the both the costs intended to be covered by the prior, invalidly executed, Agreement and the final design engineering costs. Caltrans will pay RT in accordance with the California Prompt Payment Act, codified in Government Code Section 927 et seq. The agreement allows RT to be completely reimbursed, in arrears, for all design costs, including staff costs, incurred in support of the Caltrans project. The Service Contract is for design work only. A separate agreement will be prepared, and brought to the Board for future approval, that provides for any relocation/construction activities.

In support of the Service Contract with Caltrans, Staff is requesting that the Board also approve Work Order No. 7 to the Contract for General Engineering Support Services (GESS) – 2010 with Kimley-Horn and Associates, Inc. The total amount to be paid under Work Order No. 7 will be \$175,212.39.

Staff recommends approval of: (1) the Service Contract with Caltrans for the Modification of the Overhead Contact System and Wayside Equipment for the "Across the Top" High Occupancy Vehicle Lane Project; and (2) Work Order No. 7 to the Contract for General Engineering Support Services (GESS) – 2010 with Kimley-Horn and Associates, Inc., contingent upon execution of the Service Contract with Caltrans.
