Mike Wiley verbalized his written report. In addition, Mr. Wiley reminded the Board that "no news continues to be good news" on the Federal level regarding the South Line. This past year, RT submitted updated financial forecast information, updated our budget and completely updated projections in revenues and expenditures. FTA has completed their review; but has not given RT any formal indication of the rating. RT is continuing to work with FTA on the environmental assessment. With FTA's support, we have reduced the review time to four months. FTA has assigned a staff person who is reviewing the chapters as we prepare them to expedite the review process.

The Governor released his proposed budget. Mr. Wiley believes it is a positive message for transit in California. The proposed budget is a maintenance of the current funding levels for the State Transit Assistance Program.

Director MacGlashan noted that she had previously requested ridership information on the Gold Line Folsom stations. Mr. Wiley indicated that staff was working on that information along with additional information on rail and bus to present to the Board.

Mr. Wiley reminded the Board that the Martin Luther King, Jr. March will be held on Monday, January 17th. RT has a team of walkers who will start at two different locations (Oak Park Community Center and Grant High School).
