DISCUSSION

On July 27, 2010, RT executed a contract with VenTek International for purchase of seven parking ticket vending machines for use at multiple light rail stations due to the expansion of RT's Park, Pay & Ride program. The Agreement included an option to purchase an additional 22 machines. RT would like to exercise its option to purchase four additional parking ticket vending machines; however, the option to purchase these additional machines, at the Bidder's unit price listed on the Bid Pricing Form, expires 12 months from the Effective Date of the Contract or July 26, 2011. VenTek International has offered to extend the option period up to a maximum of 36 months, if desired by RT.

At this time, Staff is working on identifying a funding source in order to purchase the additional four machines. Staff requests that the Board delegate authority to the General Manager/CEO to approve a contract amendment exercising the option to purchase an additional four machines and extend the option period by 36 months from the contract effective date, once funding has been identified
