## DISCUSSION

Under Resolution No. 12-06-0080, the Board authorized the solicitation of bids for the purchase of one aerial platform truck. RT's Light Rail Division has a need to purchase an aerial platform truck, equipped with railgear, to perform overhead catenary system maintenance and trim trees above the electrical distribution system, among other uses. RT's current platform truck does not meet California Air Resource Board (CARB) standards and must be replaced as soon as possible. A cost-analysis has proven that a required re-power of RT's current platform truck would not be cost effective. In the meantime, RT has been renting a platform truck at a rate of \$3,500 per month. These costs will be eliminated with the purchase of a new aerial platform truck.

Staff released the Invitation to Bid (ITB) on June 21, 2012 and publicly advertised it in publications of general circulation in accordance with RT's standard operating procedures. On July 19, 2012, RT received one bid from Riverview International Trucks, LLC for \$309,998.69. This price is comparable to the Independent Cost Estimate that staff completed prior to releasing the ITB and is therefore considered fair and reasonable.

Staff recommends that the Board award a contract to Riverview International Trucks, LLC for an amount not to exceed \$309,998.69, plus applicable sales tax.
