RECOMMENDED ACTION

Adopt Resolution No. 12-08-____, Authorize Solicitation of Bids for the Relocation of the Sacramento Area Sewer District (SASD) Pump Station - South Sacramento Corridor Phase 2 (SSCP2) Project.

FISCAL IMPACT

The above action does not involve the expenditure of funds. The contract award, which will involve the expenditure of funds, will be presented to the Board as a future action. The current engineer's estimate is within the South Sacramento Corridor Phase 2 Project budget.

DISCUSSION

The South Sacramento Corridor Phase 2 (SSCP2) Project requires the Sacramento Area Sewer District (SASD) Pump Station to be relocated. The proposed light rail alignment along Cosumnes River Boulevard runs through the existing SASD pump station at the Northeast corner of Center Parkway. The area is constrained by the Union House Creek to the North and Cosumnes River Boulevard to the South. The new location of the Pump Station determined in the Final Environmental Impact Report is at the Southeast corner of Center Parkway and Cosumnes River Boulevard on a parcel of land acquired by Regional Transit (RT) from Los Rios Community College District.

Relocation of the SASD Pump Station is considered a utility relocation activity. FTA allows the advancement of utility relocation work under pre-award authority once the project receives federal environmental approval. It is RT's intent to advance utility relocation required prior to the award of the Civil, Track, Systems and Stations Contract to minimize delays in that work.

Relocation activities included in the contract will include relocation of the piping, valves, gates, pumps, related appurtenances, manholes, electric control panels, cabinets, lighting, paving and enclosure. This scope of work has been coordinated with SASD and an agreement has been executed that defines the roles and responsibilities for this work.
