DISCUSSION

On December 10, 2007, the Board authorized solicitation of proposals for Project Control Services for South Sacramento Corridor Phase II project (Project). The Project is a 4.3-mile extension of the existing South Sacramento Corridor Phase I project, beginning at the existing Meadowview Station and ending at Cosumnes River College. The Project includes four stations located at Morrison Creek, Franklin Boulevard, Center Parkway, and Cosumnes River College.

On February 25, 2008, the Board awarded URS Corporation the Project Control Services contract, with a maximum total consideration of \$4,000,000 with a four year contract term. RT executed the

Subject: Approve Second Amendment to the Contract with URS Corporation and Approve Work Order No. 6 for Project Control Services for the South Sacramento Corridor Phase II Project

contract on March 28, 2008. On February 27, 2012, the Board approved the first amendment to this contract, which extended the term to one year after revenue operations commence on the Project. Five work orders have been issued to date for a total not to exceed amount of \$2,445,075.

The total consideration for Work Order No. 6 will be for a not-to-exceed amount of \$2,196,807. URS will continue to provide project control functions for the Project during construction and close-out of the Project. Specifically, Work Order 6 will include the following construction-related activities/documents.

- Master Project Schedule
- Cost Control System
- Design, Develop and Manage Schedule/Cost/Document Control Reports/Graphics
- Project Cost Estimate
- Schedule Coordinating on all Construction and Utility Work
- Right-of-Way Schedule Coordination
- Cost Report
- Progress Report
- Quarterly or Monthly Project Status Reports
- FTA Quarterly Meetings
- Interface Chart that Depicts the Roles and Responsibilities of Both Parties
- Support of RT Management Team in Schedule, Cost and Document Control through Close-Out of the Project
- Other Project Documents and Tasks Requested by RT

The original total contract consideration of \$4,000,000 was intended to cover the entire project through completion. Due to unforeseen circumstances, the project completion schedule slipped by about four years. Because of this, the consultant's services have been delayed and will now be required for several more years for the Project. Work Order No. 6, if approved, results in the need for a second amendment to the contract with URS Corporation to increase the total consideration by \$641,882 for a total of \$4,641,882.

Staff recommends Board approval of the Second Amendment to the Contract with URS Corporation to increase total consideration to \$4,641,882 and also approve Work Order No. 6, for a not-to-exceed amount of \$2,196,807, to continue Project Control services for the South Sacramento Corridor Phase II Project.
