ISSUE

Setting a public hearing to consider adoption of a Resolution of Necessity for property located at 7651 Laurie Way, further identified as Sacramento County Assessor's Parcel Number 053-0053-024 – Ike C. Bell, Jr.

RECOMMENDED ACTION

Adopt Resolution No. 12-12-_____, Setting a Public Hearing to Consider Adoption of a Resolution of Necessity for Property located at 7651 Laurie Way, Further Identified as Sacramento County Assessor's Parcel Number 053-0053-024.

FISCAL IMPACT

DISCUSSION

A portion of the property located at 7651 Laurie Way, (Sacramento County Assessor's parcel Number 053-0053-024) "the Subject Property" is needed for construction of RT's South Sacramento Corridor Phase 2 Project (Project).

On May 23, 2012, pursuant to authority granted by the Board, RT made a formal offer in the amount of its approved appraised value to the owner-of-record's Trustee to purchase a portion of the subject property pursuant to Government Code Section 7267.2. Trustee countered RT's offer at over double the appraised value stating that the value of the Subject Property's landscaping had not been adequately assessed. Trustee was advised of his right to have his own appraisal done, but not yet exercised his right to have his own appraisal done at RT's expense. Owner does not object to the Project, but takes issues with the offer price. Negotiations with the Trustee are ongoing; however, staff believes that moving forward with a Resolution of Necessity is in the best interest of the Project.

State law requires that RT hold a public hearing regarding the intent to adopt a Resolution of Necessity prior to filing an action in eminent domain, give notice to all persons listed on the last equalized County assessment roll, and allow at least 15 days for owners to respond to the notice. At the hearing, staff will present the need and necessity for the property. Owners and any others with an interest in the property will be given an opportunity to be heard. Adoption of the Resolution of Necessity requires a two-thirds vote of the Board.
