Subject: Setting a Public Hearing to Consider Adoption of Resolution of Necessity for Property Located at 7663 Laurie Way

ISSUE

Setting a public hearing to consider adoption of a Resolution of Necessity for property located at 7663 Laurie Way, further identified as Sacramento County Assessor's Parcel Number 053-0053-027.

RECOMMENDED ACTION

Adopt Resolution No. 12-07- _____, Setting a Public Hearing to Consider Adoption of a Resolution of Necessity for Property Located at 7663 Laurie Way, Further Identified as Sacramento County Assessor's Parcel Number 053-0053-027.

DISCUSSION

A portion of the property located at 7663 Laurie Way, (Sacramento County Assessor's Parcel Number 053-0053-027) is needed for construction of RT's South Sacramento Corridor Phase 2 Project (SSCP2).

On May 15, 2012, pursuant to authority granted by the Board, RT made a formal offer in the amount of its approved appraisal to the owner-of-record to purchase a portion of the subject property pursuant to Government Code Section 7267.2. Negotiations with the owner is ongoing. However, RT and RT's real estate consultant believe that moving forward with a Resolution of Necessity is in the best interest of the project due to the owner's list of counter offer issues and RT's construction schedule. As a result, this transaction may not be concluded voluntarily and it appears this acquisition may require resorting to the eminent domain process.

State law requires that RT hold a public hearing regarding the intent to adopt a Resolution of Necessity prior to filing an action in eminent domain, give notice to all persons listed on the last equalized County assessment roll, and allow at least 15 days for owners to respond to the notice.

At the hearing, staff will present the need and necessity for the property. Owners and any others with an interest in the property will be given an opportunity to be heard. Adoption of the Resolution of Necessity requires a two-thirds vote of the Board.
