Subject: Rejecting All Bids and Authorizing Release of an Invitation to Bid (ITB) for Purchase of Aerial Platform Truck

ISSUE

Whether or not to Reject All Bids and Authorize Release of an Invitation to Bid (ITB) for Purchase of Aerial Platform Truck

RECOMMENDED ACTION

Adopt Resolution No. 12-06-____, Reject All Bids and Authorize Release of an Invitation to Bid (ITB) for Purchase of Aerial Platform Truck

FISCAL IMPACT

There is no fiscal impact as a result of this action. The contract award, which will involve the expenditure of funds, will be presented to the Board as a future action. Staff has secured grant funding to pay for the acquisition. Details will be provided when the contract is awarded.

DISCUSSION

Under Resolution No. 12-03-0037, dated March 12, 2012, the Board authorized the solicitation of bids for Purchase of Aerial Devices for RT's Light Rail Division. These devices include one aerial platform truck and one aerial bucket truck, both including railgear. The solicitation was released on March 29, 2012 and was publicly advertised.

On May 3, 2012, staff opened the following two bids:

<u>Bidder</u>	Item	Total Bid Price
Riverview International Trucks	Platform Truck & Railgear	\$305,273.42
Altec Industries	Bucket Truck & Railgear	\$111,285.67

Because the total for both trucks exceeds RT's budget of \$341,000, staff has chosen to purchase the platform truck only. RT's current platform truck does not meet current California Air Resource Board (CARB) standards and must be replaced as soon as possible. Staff has elected not to purchase a bucket truck at this time due to lack of funding. After a thorough review of Riverview International Trucks' bid, staff has deemed it non-responsive because Bid Form 7.6, FTA Buy America Certificate, was not completed correctly.

Staff is requesting that the Board reject all bids and authorize release of an ITB for the purchase of one aerial platform truck.
