DISCUSSION

Under the General Manager/CEO's authority, RT entered into a contract with retired RT employee, Bob Wenker on June 9, 2010 to work under the direction of RT's IT Project Coordinator. On January 10, 2011, the Board approved the First Amendment to Mr. Wenker's Contract, extending the not-to-exceed amount of the contract by \$50,000 to \$80,000. On April 25, 2011, the Board approved the Second Amendment to Mr. Wenker's Contract, extending the term of the contract to December 31, 2011. On November 14, 2011, the Board approved the Third Amendment to Mr. Wenker's Contract, extending the not-to-exceed amount of the contract by \$20,000 to \$100,000, and extending the term of the contract to March 31, 2012. On March 12, 2012, the Board approved the Fourth Amendment to Mr. Wenker's Contract, extending the term of the contract to June 30, 2012.

Mr. Wenker is providing logistical assistance to the Project Coordinator for the Digital Messaging Sign (DMS) II Project and the Rail Infrastructure Hardening, Surveillance, and Monitoring Project by preparing project schedules, written communications, reports, equipment requisitions, project billings, inventory management, asset tagging, equipment configuration, vendor communications
