DISCUSSION

RT entered into a revenue vehicle tire lease and services contract with Michelin North America, Inc., on March 30, 2012. Studies continue to indicate that tire lease programs provide the lowest cost per mile. Staff has recommended the continued practice of tire lease agreements.

After the Contract was in place, staff noticed that the Group D tire size (245/70R19.5) listed in the ITB was incorrect. The correct tire size for Group D is 255/70R22.5. These tires are equipped on 3 of RT's 29' El Dorado MST II vehicles (model year 2006). The estimated annual mileage for these vehicles is 29,628 miles.

Michelin North America, Inc., submitted pricing for the correct tire size that is lower than the pricing submitted in their bid for the original tire size listed in the ITB. This resulted in a cost savings to RT of \$1,381.26 over a 5-year term. Please refer to the tables below:

An additional tire group and size is also needed for the addition of 6 El Dorado Ford F-550 chassis vehicles to RT's current fleet. These vehicles were procured and received after the receipt of bids for the current contract. The new tire size, to be added as Group "E", is 225/70R19.5. The estimated annual mileage for these vehicles is 294,996 miles.

Michelin North America, Inc., has provided pricing for the addition of Group E as follows:
