Subject: Approving the Second Amendment to Contract with Paragon Partners Ltd. for Right of Way Acquisition & Relocation Services for South Sacramento Corridor Phase II and Approving Amendment 2 to Work Order Number 3

March 28, 2011, the Board approved the First Amendment to the contract which increased the total consideration by \$400,000 to \$700,000. The contract provides for real estate support services related to the South Sacramento Corridor Phase 2 Project (SSCP2) also known as the Blue Line to Cosumnes River College light rail extension. Work is performed on a Work Order basis. Three Work Orders have been executed and the not-to-exceed amount of \$700,000 has nearly been reached. Due to the extensive work related to the SSCP2 Initial Study/Environmental Assessment (IS/EA) effort which was completed in October 2011, Paragon continues to play a critical role in securing the right of way needed for the SSCP2 extension. More work is needed, including a second amendment to Work Order No. 3, which, if approved, would exceed the \$700,000 authorized amount. Staff proposes to increase the contract not-to-exceed amount by \$200,000 to bring the total contract amount to \$900,000. This amount will complete the real estate services for this project barring any unforeseen issues. There is no change to the scope of services for this contract.

The requested second amendment will allow Paragon Partners Ltd. staff to continue work on the necessary right of way activities and to also coordinate with RT staff to complete the various tasks to secure control of the right of way for construction and related purposes. Activities include oversight and negotiation of acquisitions, appraisals, relocations, property management and additional right of way activity related to SSCP2 IS/EA properties.

Staff recommends the Board approve both the Second Amendment for Right of Way Acquisition & Relocation Services for the South Sacramento Corridor Phase 2 Project with Paragon Partners Ltd., wherein the total consideration is increased by \$200,000 to \$900,000, and the Second Amendment to Work Order No. 3 wherein the total consideration is increased by \$275,000, from \$450,000 to \$725,000 to continue providing real estate support services.
