DISCUSSION

In January 2012, The General Manager/CEO authorized issuance of an Invitation to Bid (ITB) for the purchase of a stand-by emergency power generator for RT's facilities at 1225 R Street. Shortly after the ITB was issued, RT's Chief Counsel determined that installation of a stand-by power generator constituted a "project" for CEQA purposes and required environmental evaluation. Consequently, in April 2012, the General Manager/CEO issued a Work Order to Atkins North America Inc., directing the firm to conduct an environmental study of the stand-by emergency power generator installation project. A Negative Declaration was prepared and submitted to the Board for approval in July. On July 23, 2012, the Board approved the Negative Declaration and the Project for the Installation of Operation of a Stand-By Emergency Power Generator at 1225 R Street (Project). Upon approval of the Project, staff completed the solicitation and on August 7, 2012, the following bids were received:

RT issued 4 addendums to this ITB, of which each bidder acknowledged receipt. The 4th addendum consisted of a revised Bid Form 4.2, Bid Pricing Form adding Bid Item No. 8 for an 8'-0" Decorative Metal Fence with 3'-0" Gate. Bockmon & Woody Electric Company, Inc. the apparent low bidder, submitted its bid with all the correct bid forms and has been deemed responsive and responsible. Gamill Electric, Inc. submitted the old Bid Pricing Form 4.2 with its bid that did not include Bid Item No. 8, therefore its bid was deemed not responsive due to not bidding a complete project.

The Engineer's estimate for this procurement was \$99,000.00, not including tax. The total project budget (\$430,000) is to fund generators at multiple District facilities. Sufficient funds remain to install and/or replace generators at other District facilities. Staff has evaluated the low bid and has determined it to be fair and reasonable.

Staff recommends awarding a contract to provide and install a Stand-By Emergency Power Generator at 1225 R Street to Bockmon & Woody Electric Company, Inc., in an amount not to exceed \$130,250.00, plus applicable sales tax.
