DISCUSSION

On May 13, 2013, the RT Board authorized staff to release a Request for Proposals (RFP) for Health and Welfare Benefit Consulting Services for a 3-year term, with 2 option years.

Staff released the RFP on May 15, 2013, advertised the solicitation in publications of general circulation and posted it on RT's website under Contracting Opportunities. Twenty-one firms received the RFP. On June 17 2013, RT received 3 responsive proposals from: Aon Hewitt, Keenan & Associates, and Wells Fargo Insurance Services. The Selection Committee, consisting of Mark Lonergan, Chief Operating Officer; Donna Bonnel, Director, Human Resources; Brent Bernegger, Director, Finance; June Moua, Senior Human Resources Analyst; and Paula McNeal, Human Resources Analyst II; reviewed the written proposals. The qualifying criteria included Project Understanding, Project Staffing and Experience, Project Work Plan, and Price. The Selection Committee completed its evaluation of the written proposals and based on the results, the Committee determined that oral presentations were not needed. Keenan & Associates proposed a project team with experience in the public sector that was unmatched. The evaluation committee also considered the pricing of the 2 option years. Keenan & Associates' price is 5% higher than Aon Hewitt's price and 23% lower than Wells Fargo Insurance Services' price, and was deemed to be fair and reasonable by Procurement staff.
