<u>ISSUE</u>

Whether or not to reject the bid and authorize resolicitation of bids for purchase of train to wayside communication equipment for the South Sacramento Corridor Phase 2 Project.

Adopt Resolution No. 13-12-_____, Rejecting the Bid and Authorizing Resolicitation of Bids for Purchase of Train to Wayside Communication Equipment for the South Sacramento Corridor Phase 2 Project.

FISCAL IMPACT

DISCUSSION

On August 27, 2012, the Board adopted Resolution 12-08-0135, authorizing the General Manager/CEO to release Bid Documents for certain owner-furnished materials for the South Sacramento Corridor Phase 2 Project (SSCP2), including Train to Wayside Communication (TWC) Equipment. The Invitation to Bid (ITB) for TWC equipment was released on October 10, 2013 and advertised pursuant to the Procurement Ordinance.

On November 14, 2013, the following bid was received:

Vecom USA, LLC \$509,652.00

The bid from Vecom USA, LLC (Vecom) was the only bid received but was deemed non-responsive because Vecom did not submit bid security as expressly required in the ITB. Because Vecom was the only company to provide a bid, there is no successful bidder.

Staff recommends that the Board reject the bid by Vecom and authorize the General Manager/CEO to release and advertise for the ITB for the purchase of Train to Wayside Equipment for the South Sacramento Corridor Phase 2 Project.
