DISCUSSION

On November 12, 2012, the Board authorized solicitation of Bids for Relocation of (S-150) Center Parkway Lift Station for the South Sacramento Corridor Phase 2 Project (SSCP2).

The existing S-150 Center Parkway Lift Station is located at the Northeast corner of Center Parkway and Cosumnes River Boulevard and conflicts directly with the proposed track alignment of the SSCP2 Project. After discussions, the Sacramento Area Sewer District (SASD) agreed to relocate the S-150 Lift Station to the Southeast corner of Center Parkway and Cosumnes River Boulevard.
