#### **ISSUE**

Whether or not to approve project related amendments to the FY 2013 Capital Budget and FY 2013 Operating Budget.

### RECOMMENDED ACTION

Adopt Resolution 13-06-\_\_\_\_\_, Approving Amendments to the FY 2013 Capital Budget and FY 2013 Operating Budget.

### **FISCAL IMPACT**

The proposed changes increase the FY 2013 Capital Budget revenues by \$9,616,759 and increase the FY 2013 Operating Budget revenues by \$2,074,886.

### **DISCUSSION**

RT's annual budgeting process includes Board adoption of budgets that reflect RT's expected funding at the time of preparation. Periodically, changes to funding require revisions to the project budgets after the Capital Budget is adopted. Staff has identified such necessary revisions due to recent funding authorizations, grant awards, or developments on various projects for either RT or RT subrecipients. Board action is required to amend the changes into both the FY 2013 Operating and Capital Budgets. The complete list of proposed changes is detailed on Exhibit A to the Resolution.

The primary purpose of this issue paper is to receive Board approval to revise the capital project budgets to correct amounts for those capital revenues currently requested on Federal and State grant applications. In addition, there are some grants that are operating budget related, that have revised revenues as well.

The proposed amendments adjust the amount of FY 2013 5307, 5309 New Starts, 5337, and 5339 Federal funding for RT and RT's subrecipients These amounts have been approved by SACOG's Board where applicable, and are consistent with the approved FTA apportionments for these funding sources. RT will be submitting grant applications to FTA consistent with these funding amounts.

Additional amendments reflect state Proposition 1B PTMISEA and SLPP funding amounts recently awarded to RT for capital projects.

Subject: Approving Amendments to the FY 2013 Capital and Operating Budgets

The balances of the amendments reflect internal funding transfers or corrections and, in some instances, include transfers of small amounts of funding from operations for specific capital project needs.

All of these amendments represent changes in funding for the FY2013 Operating and Capital Budgets that have not yet been recognized.

## FY 2013 Operating Budget and projected year-end results

The adjustments to Federal and State revenues presented in this issue paper and required for filing grant applications, increases the FY 2013 Operating Budget revenues by \$2,074,886., while the adjustments to the Local Transportation Funding (LTF) revenue is projected to be approximately \$2.0 million less than currently budgeted in the FY 2013 Revised Operating Budget.

The reduced LTF amount is included in the FY 2014 Preliminary Operating Budget as prior year LTF revenue, as discussed in prior Board meetings, and is related to the timing of when the LTF funds are released by Sacramento County and the adoption or revision of SACOG Finding of Apportionments, which controls when the funds are available to RT.

Therefore, this revenue adjustment doesn't change the projected reserve amount. Staff projects \$3.3 million will be available to designate as reserves at the end of FY 2013 as shown in the FY 2014 Operating Budget.

Staff recommends Board approval for the proposed capital and operating program changes as provided in Exhibit A.
