#### DISCUSSION

On November 12, 2012, the Board approved (Resolution No. 12-11-0172) the First Amendment to the Personal Services Contract for Temporary Employment with Tino Bamberger as the Security Program Specialist.

Federal and State Regulators have mandated Regional Transit (RT) to enact numerous security program changes and enhancements since the September 11, 2001 attacks. To meet these requirements RT needed to dedicate an individual from RT Police Services (RTPS) to develop and manage these programs. Failure to meet these mandates would put RT at risk of losing funding and/or having operations suspended by regulatory agencies on both the state and federal level. RT selected and assigned a Police Officer assigned to RTPS, Tino Bamberger, to this new position.

Because Mr. Bamberger's tasks were primarily regulatory mandates, it was necessary to fill his position, which became vacant upon his retirement from the Sacramento Police Department in

2011. The position required a person who had specialized knowledge, both security and transit experience and specific training and skills related to the subject matter. Mr. Bamberger was hired as an RT contractor upon retiring from the police department. RT has been able to realize a yearly savings of over \$96,000 by converting his position from a Sacramento Police Department employee to a Personal Service Contract without any significant loss of capabilities.

RT has an ongoing need for Mr. Bamberger as an RT contractor for RTPS on a part-time basis. In that capacity, he will continue to perform the tasks that are his current responsibilities. His primary, among other duties include:

- Maintaining RT's System Security Plan (SSP). The SSP is mandated by the California Public Utilities Commision (CPUC) under General Order 164-D and by the Federal Transit Administration (FTA) / Transportation Security Administration (TSA) under 49 CFR 659.19. RT's SSP was created by Mr. Bamberger.
- Regularly updating and maintaining RT's Threat and Vulnerability Assessments (TVA).
  The TVA's are also mandated by CPUC General Order 164-D and by the FTA/TSA under
  49 CFR 659.23. TVA's are required for all aspects of operations and must be integrated
  with the safety certification process. RT's TVA's were created by Mr. Bamberger and have
  been audited several times by both the CPUC and the FTA/TSA and have never been
  found to be deficient.
- Responsibility for all regulatory security audits. This would include the yearly CPUC internal audits, the CPUC triennial audits, the FTA/TSA biennial BASE audit and any other audits to which RT is subject. Mr. Bamberger has been responsible for all of RT's regulatory security audits for several years. The last audit received multiple industry commendations for "best practices." This includes creating departmental Standard Operating Procedures (SOP) to address audit issues.
- Performing the security portion of Preliminary Hazard Analysis projects as required by regulation for all extensions. Also, performing Crime Prevention Through Environmental Design (CPTED) assessments for RT, whether in response to regulations for new/renovation projects or to address criminal issues existing within the current system.
- Continuing to act as the grant writer for security related grants. Mr. Bamberger has extensive experience in this area and has secured well over a million dollars for RT.
- Drafting exercise plans and after-action reports for RT's exercises and drills.
- Producing monthly crime statistic reports. Acting as RTPS's crime analyst. Continuing to be responsible for RT's monthly entries into the FTA's National Transit Database (NTD) as required by Federal regulation.

Performing other related tasks as directed by RT/RTPS management.

All of the tasks Mr. Bamberger performs are either regulatory mandates or are essential to the operation of RT and RTPS. Mr. Bamberger has the required knowledge, experience, and expertise to perform these tasks. Mr. Bamberger has created many of the programs and documents that are relied on in RTPS. Additionally, he has established relationships with both federal and state auditors, and grant managers.

The total funding for Mr. Bamberger's contract is about to be exhausted and RT is still in need of his services. As such, RT staff would like to amend Mr. Bamberger's contract to add funding. The Second Amendment will increase the total consideration by \$40,000 from \$84,000 to \$124,000.

Staff recommends the approval of the Second Amendment to the Personal Services Contract for Temporary Employment with Tino Bamberger as the Security Program Specialist.
