## DISCUSSION

RT has been using the services of the Sacramento County Sheriff's Work Project crew for landscape maintenance, station cleaning and cleaning within RT's right of way. Through this Project, RT receives free inmate labor with minimal compensation for deputy supervision. Inmates participating in this Project provide a significant portion of labor necessary to maintain RT's landscaping, stations and right of way.

The Sixth Amendment to the previous Contract dated September 28, 2009 decreased the van reimbursement rate to \$250 which remains unchanged. The hourly and shift rate for the Deputy Sheriff will increase from the \$657 per eight hour shift paid under the previous Contract to \$685 per eight hour shift in this new Contract, in conjunction with the established rates for Deputies authorized by the County Board of Supervisors. The services provided by the Project crew includes but is not limited to maintenance of existing operating light rail corridors (right of way and 50 light rail stations); future use properties e.g., Calvine/Auberry, Poplar; abandoned right of way (Sutterville Road and Freeport Boulevard); and providing needed assistance to the 5 Facilities Maintenance employees who perform these essential functions.

Staff has been pleased with the performance of the Project crew and is proposing a new three year agreement to provide services at \$209,000 per year. Staff recommends that the Board approve the Contract with the County of Sacramento for Sheriff's Work Project.
