DISCUSSION

On February 9, 2015, the RT Board of Directors approved the release of an Invitation to Bid (ITB) for Roll Off and Front Load Waste and Recycling Container Rental and Service for a 3-year period with the option to renew for two 1-year periods. Bidders could place bids on any or all of the following bid alternatives: 1) Alternative A, waste only, 2) Alternative B, recycling only, or 3) Alternative C, waste and recycling. Alternative C was to be bid on an "All or None" basis, a conditional bid that requires the purchase of all services on which bids are offered and bidder declines to accept award on individual services. On February 13, 2015, the bids were advertised in publications of general circulation, posted on RT's website under Career and Business Opportunities and mailed to qualified firms.

On March 16, 2015, bids were received from Allied Waste Services of NA, LLC dba Republic Services of Sacramento; Atlas Disposal Industries, LLC; and USA Waste of California, Inc. dba Sac Val Disposal. All 3 firms bid Alternative C, All or None. Their bids for the 3 base years of the contract are as follows:

Subject: Awarding a Contract to Allied Waste Services of NA, LLC dba Republic Services of Sacramento for Roll Off and Front Load Waste and Recycling Container Rental and Service

During the review of the bids, Sacramento Regional Transit District (RT) Procurement staff discovered that all of the bids contained mathematical errors. In accordance with the ITB, General Conditions and Instruction to Bidders, Article 1.10, Mathematical Errors, staff disregarded computations that contained obvious mathematical errors and corrected the errors to compute the total amount bid. Staff also corrected computations by multiplying the item price by the quantity for that item. Correcting the mathematical errors did not change the position of the apparent low bidder. The bids listed at the bottom of page 1 are corrected figures. Staff determined that Allied Waste Services of NA, LLC dba Republic Services of Sacramento is the lowest responsive bidder. A Notice of Intent to Recommend Award of Contract was issued to Allied Waste Services of NA, LLC dba Republic Services of Sacramento on March 18, 2015.
