# General Manager's Report February 23, 2015

#### **GOVERNMENT AFFAIRS UPDATE**

#### **FEDERAL**

Congress is not in session this week. Members will return for legislative business on February 24.

A bipartisan group of House lawmakers is working on legislation that would create a joint congressional panel to find a permanent fix for the Highway Trust fund that is due to run out of money by June. House Ways and Means member James Renacci, (R-OH), said the group is considering whether unspecified triggers could compel action, but conceded the proposal could face skepticism from lawmakers who feel such committees have a mixed track record in solving problems. Ways and Means Chairman Paul Ryan (R-WI) backs a long-term funding fix for the Highway fund, but has yet to endorse a special panel to examine it. Rep. Renacci's group, made up of both Ways and Means members and others, is also looking at options to keep the Highway Trust Fund going for 10 years or more and has not dismissed an increase in the gas tax, despite resistance from GOP leaders. Rep. Bill Pascrell, Jr. (D-NJ) who is working on the proposal, said he hoped to introduce a bill "within the next month."

Appropriations season is off to a rocky start as the majority is having difficulty finishing last year's unresolved FY15 Homeland Security Appropriations bill. GOP efforts to move House-passed funding legislation (HR 240) with immigration riders attached has faced sharp resistance from Senate Democrats, who have blocked any action due to the add-on provisions. For now, the minority appears to have the upper hand as their caucus is united in a call for a clean funding bill and the Senate majority is unable to move the House plan. The Senate Majority Leader has limited options with the threat of a DHS shutdown in five scheduled work days. This initial skirmish will likely impact the effort to move FY16 appropriations bills which Congress will begin drafting in the spring. The ability of the majority to move all 12 FY16 appropriations bills under regular order appears to have diminished significantly.
