DISCUSSION

The Blue Line to Cosumnes River College project (Project), also known as the South Sacramento Corridor Phase 2 project, will extend Sacramento Regional Transit District's (RT's) light rail service from its existing terminus at Meadowview Road south and east 4.3 miles to Cosumnes River College (CRC).

The additional Station Design Services required to complete Task 3 – Construction Support Services are a result of unanticipated assistance needed by the construction contractor. Construction challenges and delays in completing offsite fabrications and on-site station construction have increased the amount of design support required, forcing RT to extend the duration of administrative support provided by MFDB and its subconsultants.

In addition, MFDB's structural engineering subconsultant, Miyamoto International, has also encountered additional time requirements during steel and precast concrete off-site fabrication and on-site installation. There have continued to be contractor deviations that required structural input to help resolve, beyond what was anticipated at the time of the previous amendment.
