DISCUSSION

On July 11, 2014, RT entered into a Contract with Weintraub Tobin Chediak Coleman Grodin Law Corporation (Weintraub Tobin) to provide legal services to assist RT's Chief Counsel in the matter of Jones, et al. v. Sacramento Regional Transit District (Jones).

The lawsuit is ongoing and the total consideration allowable under the Principal Agreement will soon be exceeded because of the complexity of the case and the number of plaintiffs involved. Consequently, RT staff is requesting that the total contract consideration be increased by \$100,000, taking the total contract consideration to \$350,000.

As permitted under Section 1.405.B.3. of RT's Procurement Ordinance, RT's Chief Counsel selected Weintraub Tobin to assist with the Jones matter after performing an informal solicitation and seeking out bids from three different law firms specializing in Employment litigation. Weintraub Tobin's proposal was deemed by the Chief Counsel to be the most advantageous and responsive to RT's needs. The General Manager/CEO awarded a contract to Weintraub Tobin for an amount not to exceed \$100,000.

The total consideration is about to be exceeded and RT has a continuing need for Weintraub's services. Because of the nature of the services being provided, the Board has the authority under RT's Procurement Ordinance (Section 1.405.B.3 of Title I of RT's Administrative Code)
