# General Manager's Report March 23, 2015

#### **GOVERNMENT AFFAIRS UPDATE**

#### **FEDERAL**

The House and Senate are both in session this week. Both chambers will be in session for the next two weeks before taking a two-week holiday recess.

On March 17, the House Transportation and Infrastructure Committee held a hearing titled, "Surface Transportation Reauthorization Bill: Laying the Foundation for U.S. Economic Growth and Job Creation, Part II." Scheduled to testify were the Honorable Patrick McCrory, Governor, State of North Carolina (on behalf of the National Governors Association); The Honorable Ralph Becker, Mayor, Salt Lake City (on behalf of the National League of Cities); and the Honorable John Cox, Director, Wyoming Department of Transportation (on behalf of the American Association of State Highway and Transportation Officials).

On March 18, Transportation Secretary Anthony Foxx testified before the Senate Appropriations THUD subcommittee regarding the President's FY16 budget request.

## **Brown Administration**

Strategic Growth Council-Affordable Housing and Sustainable Community (AHSC) Grants

The Strategic Growth Council is responsible for evaluating these "cap and trade" revenue-funded grants submitted in February and communities around the state are anxiously awaiting the results of their review of submitted concept proposals. All AHSC grant applicants will be notified of the results of their concept proposal reviews with successful applications posted to the Council website today. Communities with successful full applications will move forward to complete their application process before awards will be made in later this spring.

#### Legislature

Special Elections – State Senate

Special elections to fill seats of three Senators that were elected to Congress were conducted last week in the 7th Senate District (Contra Costa County), the 21<sup>st</sup> District (Northern LA County) and the 37th District (Southern Orange County).

**7<sup>th</sup> Senate District:** Current Assembly Member Bonilla and Orinda Mayor Steven Glazier, a former advisor to Governor Brown, were the top two vote-getters and will compete in a run-off in May;

**21**<sup>st</sup> **Senate District**: Former Assembly Member, Sharon Runner, was elected to fill the term of this seat; she ran unopposed.

**37**<sup>th</sup> **Senate District**: Former Orange County Supervisor, John Moorlach appears to have clinched this seat with 50.4% of the vote over present Republican Assembly Member Dan Wagner. There remain some provisional ballots to count, so this could move into a runoff, if Moorlach's lead diminishes.

These election results will not affect the balance of power in the Senate, where Democrats hold a majority of seats, having lost their former supermajority (2/3rds, or 27 seats) in the November elections.

## AD HOC STSTEM IMPROVEMENT COMMITTEE UPDATE

The Ad-Hoc Committee held its first meeting on February 25 and provided staff with direction regarding the process we will be following for further work. The Committee formed four working groups. The Ad-Hoc Committee will meet quarterly over the next year and receive a status report from each working group. I have assigned RT staff to provide support to each working group. The assigned staff lead will schedule their working group meetings, provide a work plan, all material and information, and will be responsible for assisting the group in the development of an action plan. Each Working Group will receive detailed information regarding RT's adopted budgets (Capital and Operating), as well as future projections. They will also receive additional financial detail regarding their area of focus.

I will also be amending our contract with Wendy Hoyt to provide high level policy support to the Working Groups and Ad-Hoc Committees as needed. Under the GM's authority, our procurement staff is also working to retain the services of a consultant (Doug Carter) to provide a system level review that is designed to provide an independent analysis and recommendations identifying steps to improve RT's delivery of service in a more cost effective manner. Doug will likely be starting work in early April.
