DISCUSSION

On March 30, 2016, an Invitation to Bid was released to solicit bids for Historic Folsom Station Modifications. The reason for this project is that the UTDC light rail vehicles cannot serve the City of Folsom until the Historic Folsom Station is modified to accommodate the car body clearances of the UTDC vehicles. Staff has determined this can be accomplished by extending each of the mini-high platforms to the north, which will be accomplished by the proposed contract. Bids were due March 31, 2016.

A single bid was received from Swierstock Enterprise, Inc., doing business as Pro Builders. Staff has determined that the price is fair and reasonable.

Staff recommends that the Board award the contract for Historic Folsom Station Modifications to Swierstock Enterprise Inc., dba Pro Builders.
