DISCUSSION

Due to budget constraints and loss of staff, RT's engineering department is currently understaffed and has limited in-house structural engineering expertise. Mr. Moreno currently has a personal service contract specifically supporting various capital projects such as the System Wide Station Improvements, Bridge Inspections and Repairs, Mini-High Shelter Improvements, Metro Building Repairs, but his contract expires on December 31, 2016.

RT will continue to require Mr. Moreno's expertise as several capital projects such as the System Wide Station Improvements, Bridge Inspections and Repairs, Mini High Shelter Improvements, Morrison Creek Station, Sacramento Area Sewer District (SASD) Canopy Modifications and other capital projects will need to progress through the end of 2017. RT does not expect to hire additional staff with the capability to perform the task Mr. Moreno will be assigned in the short term, but as future capital projects develop, staff will be augmented as needed.

Because of the on-going need for structural engineering support for the System Wide Station Improvements, Bridge Inspections and Repairs, Mini High Shelter Improvements, Morrison Creek Station, SASD Canopy Modifications and other capital projects, RT has a continuing need for Mr. Moreno's services. Because Mr. Moreno's Contract is close to expiration, RT will need to execute an Amendment to the Contract with Luis Moreno to keep him on to help with various capital
