On October 26, 20165, the Board approved the Second Amendment to the Contract for Operational Assessment and Recommendations for Cost Reduction and Revenue Growth Services with Douglas Carter and MBO Partners, Inc. The purpose of the original Contract is to identify ways to improve safety, maintenance and service efforts while achieving cost savings and identifying ways to increase revenues. Pursuant to the Second Amendment approved by the Board, Mr. Carter has been continuing work on his diagnostic review modification and fare structure and pricing analysis.

Subject: Ratifying the General Manager's Modifications to the Scope of Work and Approving the Third Amendment to the Contract for Operational Assessment and Recommendations for Cost Reduction and Revenue Growth Services with Douglas Carter and MBO Partners, Inc.

In November 2015, the Sacramento Area Council of Governments (SACOG) approached RT and requested that Mr. Carter perform the following work in support of the Connect Card project, for an amount not to exceed \$25,000:

- Examine issues, punch list items and system capabilities to help identify items that must be addressed prior to launch and those that can be addressed after launch.
- Explore business process options with RT and SACOG to help make revenue service operations more successful with lower risk.
- Work with RT and SACOG to identify risks and mitigations in launching Connect Card into revenue service.

Pursuant to these discussions, Mr. Carter was directed to perform the Connect Card work.

In the interest of expediency and under the impression that the existing scope was sufficiently broad, the contract modification did not follow all of the procedural steps laid out in RT's Procurement Ordinance. However, the Procurement Ordinance provides for the ratification of such modifications when they are made by authorized RT staff, such as the General Manager/CEO. RT staff is recommending ratification in this instance. Additionally, for Mr. Carter to complete both the Connect Card work and the work authorized by the Second Amendment, \$25,000 must be added to the Contract.

Finally, pursuant to the Procurement Ordinance, staff is recommending that the Board make a finding that it was the best interest of RT to contract with Mr. Carter to perform the above-described Connect Card work. Staff determined that Mr. Carter was uniquely qualified to perform this work because of the understanding he developed of RT's strategic objectives and business processes in the diagnostic review, and his prior industry experience with smart card implementation.

The intent is that SACOG will enter into an agreement to reimburse RT for the Connect Card work. However, to date that has not occurred. Discussions on this topic are still occurring.

Staff recommends that the Board approve a Third Amendment to the Contract for Operational Assessment and Recommendations for Cost Reduction and Revenue Growth Services with Douglas Carter and MBO Partners, Inc. to formally include the Connect Card work and add sufficient funds to cover the performance of that work.

THAT, the Third Amendment to the Agreement between the Sacramento Regional Transit District, therein referred to as "RT," and Douglas Carter therein referred to as "Consultant," and MBO Partners, Inc., therein referred to as "MBO," whereby Consultant agrees to continue the work identified in the Second Amendment and to perform work in support of Connect Card, as further set forth therein, and the total consideration is increased by \$25,000, from \$274,874 to \$299,874, is hereby approved.
