DISCUSSION

On April 25, 2016, the RT Board authorized staff to release a Request for Proposals (RFP) for Compressed Natural Gas (CNG) Equipment Repair and Maintenance as the current contract expires August 12, 2016. Staff released the RFP on April 26, 2016, and the solicitation was advertised in publications of general circulation and posted on RT's website under Contracting Opportunities. On May 26, 2016, RT received two responsive proposals from Clean Energy and Trillium CNG.

The qualifying criteria in the RFP included staff experience and price. The Selection Committee scored the written proposals and the ranking by the Selection Committee resulted in Clean Energy outscoring Trillium CNG. Clean Energy's score was 270 and Trillium's 250.

The CNG equipment located at 1322 28th Street is becoming more difficult to maintain due to obsolete parts, technology changes and availability of vendors to provide services to the manufacturer's original specifications and performance standards. Clean Energy proposed a larger and much more experienced staff to work on this aging system.
