## DISCUSSION

On March 30, 2015, the General Manager/CEO awarded a contract for \$80,520 to the City of Rancho Cordova to perform weekly maintenance at the following RT light rail stations: Mather Field/Mills, Zinfandel, Cordova Town Center and Sunrise. The maintenance includes graffiti removal, cleaning and trash removal at RT's light rail station platforms, park and ride lots and the Coloma pedestrian crossing located in the City of Rancho Cordova.

The contract between RT and the City of Rancho Cordova will expire on March 31, 2016. Staff recommends the Board approve a three-month extension to the Light Rail Stations Maintenance Agreement while RT and the City of Rancho Cordova conclude negotiations.
