DISCUSSION

On September 26, 2016, the Board approved a 9-month agreement with the Department of Human Assistance for discount purchase and sale of prepaid fare media. The Fiscal Impact portion of the Issue Paper stated that RT would receive a total of \$1,706,270 for the 9-month term. After approval, DHA brought to RT's attention that the \$1,706,270 figure included the cost of a full year of ID cards and stickers, rather than a pro-rated amount reflecting the 9-month term. The fees for sticker printing costs and photo ID cards for the first 3 months of the Fiscal Year were already included in the 3-month extension (from July 1 to September 30), so only 9 months of those fees should have been included for the new 9-month contract. That change will lower the total fiscal impact for the 9-month Agreement by \$13,684; however, the total for the entire Fiscal Year will actually increase by \$46 due to a slight increase in the administrative fee. Staff is bringing this Agreement back to the Board to approve so that RT can be accurate as possible in the reporting of funds to be received.
