Mike Barnbaum – Mr. Barnbaum noted that the City of Elk Grove's Comprehensive Operational Analysis for Etran will be discussed, and is set for adoption, at the City Council meeting on April 12th.

Jeffery Tardaguila – Mr. Tardaguila wants a better identifier for patrons to pick up Etran going back to Elk Grove; is hopeful that RT is ready for bike month; noted an incident with internal communication during a Golden 1 Center event; he believes RT never tested the "quad core processor" for the Connect Card; hopes RT will include detailed information about bus shuttle services in their budget; wants to know how many tickets RT is giving away for the Amgen Tour, where is it recognized and how it is being costed.

General Manager Li reviewed the recently passed Senate Bill 1 which provides approximately \$5.2B funding annually for roads and transit, with approximately 85% funding for roads and 15% for transit. RT will use this new funding to build up RT's contingency reserve and reduce \$29M line of credit, as well as to replace permanently lost federal revenues – CMAQ funds for light rail blue line extension and lower than expected state cap and trade funds.

Mr. Li noted that RT received an upward change in RT's revenue bond rating from a negative outlook to a stable outlook with Moody's. Mr. Li commended Senior Accountant, Jamie Adelman, who has been the catalyst in ensuring that RT's Traffic Congestion Relief Program funds and other funding sources were used to maximize the debt service pay down for the revenue bonds, and working with Moody's to pull together all the required information to convey numerous positive steps that RT has taken to move RT towards its financial recovery. Mr. Li also congratulated Brent Bernegger, RT's new Vice President of Finance/Chief Financial Officer for his strong leadership and dedication.

RT's Strategic Vision and Route Optimization plans have begun with regional dialogues, including meeting with numerous regional stakeholders, and staff are continuing to schedule more presentations at community meetings, including neighborhood groups, business improvement districts, chambers, schools districts, elected official meetings and others. RT has launched a community survey to gather as much input as possible to help shape our service and understand community's priorities for a world-class public transit system. This work will lead us into the route optimization.

Mr. Li noted that in March 2017, the Amalgamated Transit Union, Local 256, signed a letter of Agreement with RT to create an additional demonstration project to provide for expanded use of the Transit Agent classification (to add 30-40 more TAs, in addition to existing 25 transit agents) while reducing the contracted security guard services. The new transit agents employed during the demonstration period will receive the same wages and benefits as current Transit Agents except they will be participating in a defined contribution retirement plan (a 3% employer contribution 457 plan), rather than the more costly traditional defined pension plan currently provided to existing employees (a 26% of employer contribution pension plan). These employees will assume duties previously performed by contracted Security Guards. This is a significant step because it will help to reduce labor cost in a positive way. Mr. Li commended Ralph Niz – ATU president and his team for their strong leadership and partnership.

Mr. Li indicated that RT's preliminary Fiscal Year 18 operating budget is actually 1% less than last year's budget due to RT's relentless pursuit of operational efficiency and business process optimization. RT plans to achieve this milestone without any changes to service and fare structure. Furthermore, RT plans to use some extra fare revenues to provide free ride days for students, and seniors 62 years and older, as a thank you to the community. RT can achieve a budget reduction without affecting service and it is due to RT's partnership and productivity improvement initiatives that are being implemented with our vendors and contractors. One of these partners is Paratransit, Inc. (PI), which provides RT's complementary paratransit service. With innovative funding reallocation, better scheduling and service enhancement initiatives, PI will save RT approximately \$3.5M in operating costs while continuing to provide quality services to the community at the same or even higher service level. Mr. Li thanked Pl's Chief Executive Officer, Tiffani Fink, for her great leadership, thanked all PI board members past and present for their guidance and leadership, thanked RT's Mobility Advisory Council (MAC) and all RT Board members and community leaders, as well as the community for their strong support. acknowledged RT's dedicated team for working so effectively with PI's counterpart to make this happen so quickly and smoothly with extensive professional preparation and negotiation. Some of these RT team leaders are Laura Ham, Brent Bernegger, Doug Vanderkar, Janice Labrado, David Goldman and many others.

Director Hansen recognized Tiffani Fink and Paratransit. Director Hansen noted that Ms. Fink has wasted no time in making improvements at her organization and doing a lot of good work.

Devra Selenis mentioned how great ridership was during the NCAA Tournament weekend and St. Patrick's Day. During that time, RT had fantastic media coverage and Devra showed a video of such coverage. RT's marketing team delivered "How to Ride" information to all the local hotels. Devra Selenis invited Adam Wong to the podium. Mr. Wong created a designated driver map that aims to prevent drunk driving by showing all the Downtown locals that serve alcohol and their proximity to light rail stations. Mr. Wong noted that he has expanded his map since this publication to include the entire RT light rail system.

Brent Bernegger provided a review of the February financials.

Director Hansen suggested that staff revisit the Fiscal Sustainability Policy.

David Goldman reviewed the highlights of the preliminary FY 18 budget. The FY 18 budget is proposed to be \$160.9 million which is down from \$162.5 million in FY 17. Twenty-five percent of RT's revenue comes from state sales tax; another 25% from local sales tax (Measure A); 20% from fares; another 20% comes from federal revenues which are decreasing; and the remaining revenues are about 10%. Mr. Goldman reviewed the preliminary capital budget and budget schedule.

Director Nottoli noted a correction on page 5 of 8 under Professional Services noting two things "anticipated cost reductions with our ADA paratransit contract by bringing..." should read "and by bringing". Director Nottoli questioned why RT is paying property taxes. April 10, 2017 Action Summary
