#### DISCUSSION

On June 12, 2017, the Board authorized the solicitation of bids for the Bus Maintenance Facility 2 (BMF2) Roof Repair.

BMF2 at McClellan Business Park has roof issues that have been elevated on the Capital Projects priority list. BMF2 houses SacRT's Community Bus Service Department, which occupies a portion of the administrative offices on the second floor. In March 2017, the California Department of Industrial Relations, Division of Occupational Health and Safety (Cal/OSHA) provided SacRT notice that the working environment within the BMF2 administrative offices required immediate attention. SacRT's Safety Department responded to Cal/OSHA's letter and remediation of the issues is underway. The roof has been inspected by SacRT staff and the roof repair is one of the required remediation items.

Staff released an Invitation to Bid (ITB) document on June 30, 2017 in accordance with SacRT's Procurement Ordinance. On July 28, 2017, the following bids were received:
