DISCUSSION

Under the General Manager/CEO's authority, SacRT entered into a Contract with Leslyn Syren on October 10, 2016 for Temporary Employment - Labor Relations support. On May 4, 2016, Ms. Syren's Contract was amended to change the title to Temporary Employment – Attorney III, to revise the scope of services to provide assistance with litigated cases, and to extend the term to October 9, 2017. SacRT has a continuing need for her services and desires to extend the term to December 31, 2017.

Staff recommend that the Board approve the Second Amendment to the Temporary Employment Contract – Attorney III, which increases the total consideration to \$90,000 and the term by 3 ½ months until December 31, 2017
