DISCUSSION

SacRT has been under contract with UniFirst Corporation (UniFirst) since March 18, 2014 for Uniform Rental and Laundry Service. Under the Collective Bargaining Agreement between SacRT and IBEW, SacRT is required to bear the total cost of purchasing, maintaining and laundering uniforms for Light Rail Maintenance, Wayside and Bus Maintenance employees.

SacRT is required to provide personal protective equipment for all personnel, and fire resistant (FR) and arc-flash rated uniforms for Wayside "Line Personnel" in accordance with state laws – Title 8, California Code of Regulations, Section 3390 – “Protection from Electric Shock” and Title 8, California Code of Regulations, Section 2320.2 – “Energized Equipment or Systems”. To comply with applicable laws and regulations, the Third Amendment to the Uniform Contract is to authorize UniFirst to replace regular uniforms with arc-flash rated FR garments for SacRT’s Wayside personnel.
