ISSUE

To nominate and elect the Chair of the RT Board of Directors for 2017 and defer the nomination and election of the Vice Chair.

RECOMMENDED ACTION

- A. Motion: Nominating and Electing a Chair of the RT Board of Directors effective January 10, 2017; and
- B. Motion: Temporarily Suspending Section 3.1.2.5 of Regional Transit's Administrative Code, Title III, "Elections" for the Election of a Vice-Chair.

FISCAL IMPACT

None as a result of this action.

DISCUSSION

RT's Enabling Act requires the nomination and election of the Board Chair at the first meeting in January of each year. (Publ. Util. Code § 102014.) Pursuant to Title III of RT's Administrative Code, the Vice-Chair must be nominated and elected at the first meeting in January of each year as well. (RT Admin. Code, Title III, § 3.1.2.5.)

At this time, the RT Board does not have a full complement of Board members, and staff is requesting that the Board suspend RT's Administrative Code until the Chair of the County Board of Supervisors selects another member to sit on the Board. After that selection is made, staff will bring back an issue paper asking the Board to nominate and elect a Vice-Chair.
