ISSUE

Whether or not to authorize solicitation of proposals for Streetcar Construction Management Services.

RECOMMENDED ACTION

Adopt Resolution No. 17-07-____, Authorizing Solicitation of Proposals for Streetcar Construction Management Services.

FISCAL IMPACT

The above action does not involve the expenditure of funds. The contract award, which will involve the expenditure of funds, will be presented to the Board as a future action.

DISCUSSION

The Downtown/Riverfront Streetcar Project (Project) is a 5.2-mile initial line that will extend from the West Sacramento Civic Center to the Midtown entertainment and retail district in the City of Sacramento. The Project is owned by the cities of West Sacramento and Sacramento (Cities). SacRT is responsible for managing the design and construction of the Project on behalf of the Cities. The line will operate with modern streetcars, and the current Project estimate is \$200 million.

The procurement of Construction Management (CM) Services for the Streetcar Project is a critical element in the advancement of the Downtown/Riverfront Streetcar Project. Selection of a CM firm at this time will allow for construction related issues to be incorporated into the preliminary designs.

The CM Services provided by the successful proposer will include a team of professionals to manage the time, cost, safety, and quality of the construction. SacRT's objective in securing CM Services is to ensure that construction contractors deliver a high-quality product, safely, on schedule, within budget, and in conformance with the applicable contract documents for the Streetcar and any associated construction activities or construction contracts.

The selected CM Consultant will provide qualified individuals with technical expertise in the engineering and construction industry. Services, as requested by SacRT, may include:

Issuance of the CM Services Request for Proposals and obtaining a CM consultant is critical to achieving these objectives.
