DISCUSSION

InAlliance, a private non-profit corporation providing vocational training for developmentally disabled individuals, has been under a contract with RT since September 1995 to provide cleaning services along RT's light rail system. In August 2004, the scope of services was expanded to include certain janitorial services at designated RT facilities. For the past several years, InAlliance has been under contract with RT to perform cleaning and janitorial services. Most recently, on December 12, 2016, the Board awarded a contract for cleaning and maintenance services to InAlliance for an amount not to exceed \$100,000.

Staff recently determined that RT should procure cleaning and maintenance services through a formal solicitation of bids, with full and open competition. Staff has developed an invitation to bid (ITB) solicitation document and will go through the procurement process, which will take approximately 3 months to complete. In the meantime, because RT has a continued need for cleaning and maintenance services, staff was able to negotiate a 3-month extension to the contract with InAlliance for continuation of services until a new contract is put in place.
