<u>ISSUE</u>

Whether to approve an Agreement for Acquisition of Easement for the City of Sacramento to construct street improvements within RT's property at 6800 Folsom Boulevard.

RECOMMENDED ACTION

Adopt Resolution No. 17-03-_____, Approving an Agreement for Acquisition of Easement for the City of Sacramento to Construct Improvements within RT's Property Located at 6800 Folsom Boulevard.

FISCAL IMPACT

Approval of the Easement Agreement would result in RT receiving a total one-time payment of \$14,800.00, which is the appraised value of the Easement based on the appraisal prepared by the City.

DISCUSSION

The City of Sacramento (City) has requested an easement to construct street improvements within a portion of RT's property.

This property is located at 6800 Folsom Boulevard (APN: 015-0010-021) and is further identified in Attachments A and B.

As part of the Folsom Boulevard Street rehabilitation project, the City will improve pedestrian, bicyclist and vehicular safety and circulation along Folsom Boulevard. The Sacramento City Council identified Folsom Boulevard as a transit-oriented retail and residential area with a specific focus on creating an inviting pedestrian and bicyclist environment. The City's goal is to provide continuous sidewalks, bike lanes, parking and planter strips along Folsom Boulevard. The Folsom Boulevard street rehabilitation project should not impact RT's operations.

The proposed improvements within the requested easement area will include new curbs, gutters, sidewalk, along with detectable warnings to comply with current Americans with Disabilities Act requirements, on each curb on the west and east corners of the driveway into RT's bus transfer facility on the south side of Folsom Boulevard.

The City would be solely responsible for the construction, use, operation, repair and maintenance of the improvements.






