SACRAMENTO REGIONAL TRANSIT DISTRICT BOARD OF DIRECTORS BOARD MEETING April 24, 2017

ROLL CALL: Roll Call was taken at 5:30 p.m. PRESENT: Directors Budge, Harris, Hume, Jennings, Kennedy, Miller, Nottoli, Schenirer, Serna and Chair Morin. Director Hansen arrived at 5:34 p.m.

PLEDGE OF ALLEGIANCE – Led by Chair Morin.

*Motion: Director Jennings moved to hear Item #5 earlier in the agenda (before Item 4); Director Budge seconded the motion. Motion carried by voice vote.

PUBLIC ADDRESSES BOARD ON MATTERS NOT ON THE AGENDA

Speakers:

Mike Barnbaum – Mr. Barnbaum provided an update on the Roseville City Council meeting of April 5; the Elk Grove City Council meeting of April 12; and the upcoming Yolo County meeting whereby the council will consider streamlining shuttle services.

W. Glover – Mr. Glover would like Regional Transit to become a fare free system.

Sarah Kerber – Ms. Kerber wanted to suggest that RT Board and staff receive additional training on Title VI compliance. Ms. Kerber would like to see free transfers reinstated. Ms. Kerber believes that the not all riders are able to take advantage of the 90 minute mobile application fare.

Jeffery Tardaguila – Mr. Tardaguila noted a Connect Card terminal problem at Cathedral Square; and wants better communication with riders. Mr. Tardaguila indicated that he had no way of utilizing anything other than cash this past Friday.

Cheryl Busby – Ms. Busby thanked Director Jennings for contacting Ms. Johnson in Oak Park in regard to a bus stop being rebuilt in the area. Ms. Busby wants RT to engage with local vendors.

Tim Ortiz – Mr. Ortiz provided his appreciation for everything that the RT Board has been doing. Mr. Ortiz sees great improvements taking place with the RT system and the behavior of the employees.

Director Hansen recommended that the speakers attend the Streetcar Steering Committee meeting on Wednesday, April 24th @ 10:30 at SACOG to provide their comments to that committee. Director Hansen also indicated that none of the money that is going through RT is money that is available to RT for anything else other than Streetcar Project, which is funded by the Cities and the federal government. The project is owned by the two cities and RT is the project manager that was hired to do the work. Director Hanson would like to have 100% low floor vehicles. Director Hansen noted that providing an update to the Mobility Advisory Council is a good idea, and suggested that the update include staff members from SACOG, RT and others.

Director Nottoli asked when the issue of the Proposition 1A funding would be coming to the Board for discussion as indicated in the February Streetcar report, and what would be asked of the Board? Henry Li noted that the report will be brought to the Board on May 22, and that staff is working on details with the regional partners. Mr. Li indicated that Proposition 1A funds are flexible funds.

ACTION: APPROVED - Director Hansen moved; Chair Morin seconded approval of items 2 and 3 as written. Motion was carried by voice vote.

Henry Li thanked Mr. Anderson for his service, and noted that there have been 8 employees who have served RT with 40 or more years of service. Currently there are 5 employees that have 38 or more years of service with the District. Starting today and

on a quarterly basis, RT will recognize employees that have 20 or more years of service at Board meetings. Today's recipients are: Gerald Alexander, Anthony Montoya, Brenda Lee, Daniel Talamantes, Jo Noble, Tim Kent, Robert O'Brien, Lauren Bartlett, Florina Gutierrez-Gordon and Joe Lentz.

Mr. Li indicated that the Sacramento Bee noted that RT's ridership has dropped. He noted that ridership has dropped in most major transit systems across the nation including Los Angeles and New York. Transit systems that had ridership increases added overnight service on popular routes, linked buses to light rail, redesigned bus networks, expanded weekend and night service, launched new routes, and cut low-ridership routes while increasing frequency on others. Mr. Li noted that staff is looking at additional initiatives to increase ridership and bring back the occasional riders on our buses and trains. Ideas to increase ridership such as bringing back transfers, distance based fares and feeder routes to light rail are just a few.

Mr. Li addressed some of the speaker's comments that some riders would not be able to enjoy the benefit. He noted that 80% of riders currently have the means to enjoy the free transfers. If cash paying customers can get a Connect Card, then they can enjoy the free transfer option as well.

RT, like many other transit agencies in the nation, has been experiencing declining ridership. To stop or reverse this trend, RT will take corrective action such as Route Optimization and other investments in RT such as pursuing additional local funding. If additional funds are obtained, RT will use the funds for: 1) fix it first projects; 2) may be used for light rail extension projects; and 3) to add back the 25% of service cuts done 10 years ago.

Staff will announce a plan to bring back transfers for those riders using the Connect Card giving customers the ability to ride between the two systems within 90 minutes. Additionally, staff is asking the Board to grant the General Manager/CEO authorization to provide a limited number of free ride days to Students K-12, individuals with disabilities and seniors over the next 6 months.

Brent Bernegger provided a review of the March 2017 financials for the District.

Director Nottoli noted that staff needs to reflect the cost of the damage in their financials from the traffic incident in Folsom and recover the loss from insurance settlements.

Director Serna thanked Mr. Li for working with staff to assess and provide a bus shelter in the South Oak Park neighborhood (Route 68) at the Fruitridge Community Collaborative.
