Subject: Approving the License Agreement for Signs with Clear Channel Outdoor

ISSUE

Whether to approve the License Agreement for Signs with Clear Channel Outdoor.

RECOMMENDED ACTION

Adopt Resolution No. 17-11-____, Approving the License Agreement for Signs with Clear Channel Outdoor.

FISCAL IMPACT

Approval of this license agreement will result in SacRT receiving annual payments of at least \$15,360 over the five-year agreement period for four existing signs plus an additional \$39,600 per year for ten years for the new proposed sign as detailed below.

DISCUSSION

In April 2008, the SacRT Board approved a five-year license agreement with Clear Channel Outdoor (Clear Channel) for existing billboards located within Sacramento Regional Transit District's (SacRT) right of way and within the Sacramento-Placerville Transportation Corridor Joint Powers Authority (JPA), further described in Attachments "A1-A4". When this agreement expired in 2013, Clear Channel Outdoor continued to pay revenue sharing fees to SacRT on a month-to-month basis, despite "no holdover" language in the License Agreement and an obligation to remove the signs upon expiration of the term. Clear Channel recently requested a new license Agreement for these locations of the License Fee but informed SacRT that the annual amounts paid to SacRT have been considerably greater than the actual revenue growth. As a result, under the terms of the new license agreement, Clear Channel made modest reductions to the license fee amounts. To offset the revenue reductions, Clear Channel has proposed the creation of an additional sign that would be located north of Highway 50 east of Redding Avenue near the 65th Street Station (see Attachment B). Clear Channel will be responsible for construction and maintenance of the new sign as well as the maintenance of the existing signs located within SacRT's and the JPA's right of way.

The proposed sign locations and sizes are identified as follows:

- 1. Freeport Boulevard
 75 Feet North of
 Florin Road
 Map (Attachment A1)
- Two Single-face illuminated 12' x 25' sign.
 Previous revenue of \$5,168 annually.
 A decrease to \$4,920 annually or 25% of gross revenue generated from sign (less any agency fees), whichever is greater. A modest rent decrease due sign earning less revenue.

- 2. <u>12th & E Street</u> Map (Attachment A2)
- Single-face illuminated 12' x 25' sign.
 Previous revenue of \$4,801 annually, revenue reduction to \$600 annually, or 25% of the annual revenue generated from sign (less any agency fees), whichever is greater.

The minimum rent will increase to \$2,400 annually, once trees are trimmed allowing for better visibility. Since this is located within the City of Sacramento, coordination with City staff will be required.

- 3. Freeport Blvd/Florin Road Map (Attachment A3)
- Double-face illuminated 12' x 25' sign. Previous revenue of \$2,400 annually. An increase to \$4,920 annually or 25% of the annual revenue-generated from sign (less any agency fees), whichever is greater.
- 4. Folsom Blvd/Mayhew Map (Attachment A4)
- Double-face illuminated 12' x 25' sign.
 Previous revenue of \$5,168 annually. A modest decrease to \$4,920 annually or 25% of annual revenue generated from sign (less any agency fees) whichever is greater. A modest rent decrease due to sign earning less revenue.

The proposed new sign:

- 5. North of Highway 50 Map (Attachment B)
- New Double-face illuminated 14' x 48' sign. Annual revenue to be \$39,600 or 25% of annual revenue from sign (less any agency fees) whichever is greater

Clear Channel is requesting the proposed new billboard sign be installed on the north side of Highway 50 east of the Redding Avenue crossing under a relocation agreement with the City of Sacramento requiring the removal of existing signs according to the City's sign code.

As with any new proposed sign, there are significant costs associated with building and placing a sign. Since Clear Channel is required to pay these upfront costs, the new agreement includes a language which prevents SacRT from terminating the License Agreement as to that sign for a period of 10 years after installation is complete. Annual payments for that sign would not start until the earlier of: (1) completion of installation; or (2) 2 years after commencement of the agreement. Because the initial design, building and construction of the sign is a significant upfront cost for Clear Channel, accepting this term was deemed reasonable.


Staff recommends approval of a License Agreement for the four existing billboard signs for a 5-year term and the new proposed billboard sign for a 10-year term.

CLEAR CHANNEL OUTDOOR SIGNS ON SACRAMENTO RT PROPERTIES


Location #1: 12th Street, west side, south of E Street:




Location #2: Freeport Blvd. west side, 500 feet north of Florin Road



Location #3: Florin Road, north side, west of Freeport Blvd.




Location #4: Folsom Blvd. east of Mayhew Road:
